<b>Full Membership</b>	<i>Membership is entitled to all privileges for the member and dependent family. (Dependent family includes any member claimed by the member as a dependent income tax exemption.) This consists of all clubhouse, social, golf, and swimming privileges.</i>
<b>Non-Resident/Out of State</b>	<b>Non-resident</b> —Privileges same as Full Membership. Restricted to persons living 40 miles or more from the club.
<b>Retired Membership</b>	<b>Retired Club Member</b> —Restricted to members 65 and older and retired. Privileges same as Full Membership.
<b>Golf Membership</b>	<b>Golf Membership</b> —Provides privileges of the golf course and clubhouse for golf associated activities only.
<b>Social</b>	<b>Social-</b> Provides privileges of the club house and surrounding areas for social events held by the club.
<b>Weekday Membership</b>	<b>Weekday Only-</b> Provides membership privileges for the golf course Monday thru Friday. Member may still play in tournaments on weekends.
<b>Class Jr.</b>	<b>Jr. Membership-</b> Provides all privileges for the member and dependent family under the age of 35. Upon turning 35 the member will fall into the category of their choosing.
<b>Pool Only</b>	<b>Pool Only-</b> Provides membership for pool facilities only. Use of other facilities is not allowed under this membership. If out of the club for two years prior members may join under this classification. <b>Payment is due in full at time of application.</b>
<b>Introductory Membership</b>	Good for one year from sign up date. Privileges are same as Class A. After one year if membership is continued member will fall in category of their choosing.
<b>Active Military</b>	Privileges are same as Class A membership for active members of the military.
